SuperSibs! Scholarships help children redefine the “cancer sibling” experience by providing needed support. Applicant must be a sibling of a child with cancer, live in the U.S., be a graduating high school senior and be attending an accredited educational institution in the upcoming semester. Two \$5,000 scholarships are available for graduating high school seniors. For more info, please visit their website at www.supersibs.org and click on the “Programs & Services” link at the top of the page, then click “SuperSibs! Scholarship Program” on the right side of the page. **The 2009 Scholarship Application deadline is closed, however, check back in November 2009 for next year’s scholarship program.**

Ronald McDonald House Charities Scholarship Program awards four separate scholarships to students from disadvantaged communities. The awards are given to the following students: 1) all students 2) Asian-Pacific students 3) African-American students and 4) Hispanic students. National Children’s Cancer Society offers college and vocational scholarships to childhood cancer survivors. Through the Beyond the Cure program, N.C.C.S. will award stipends of up to \$5,000 per academic year to survivors who have illustrated the ability to overcome difficult challenges of childhood cancer with determination and motivation. SAMFund (Surviving & Moving Forward) foundation assists cancer survivors between the ages of 17 and 35 living in the U.S. with their transition into a successful post-treatment life. The foundation distributes grants and scholarships in an effort to enable survivors to pursue their educational or professional goals. Their financial awards are not specified. This link will allow you to register in the SAMFund database and receive updates about the program. **They are not accepting applications at this time, but their next application cycle will begin in early June 2009.**

Beyond the Cure Scholarship Program provided 10 college and vocational scholarships, up to \$5,000 each, for the 2008-2009 school year. The 2009-2010 scholarship program is currently under review and the **application will be available** on their web site **at the end of February, 2009.** Check it out on their web site at www.beyondthecure.org.

National Collegiate Cancer Foundation (NCCF) \$1,000 Scholarships are awarded to cancer survivors between the ages of 18-35 who are seeking or receiving higher education and who submit the winning essays and display a “will win” attitude and overall story of cancer survivorship. Check their web site in mid summer to find out details about their proposed August 30, 2009 deadline for the 2009-2010 school year. Their web site is www.collegiatecancer.org.

Cancer for College awards scholarships to current and former cancer patients who are currently attending either a four year accredited university, junior college and/or grad school. A new feature that we will include in our newsletters is highlighting one organization in each issue. It’s important that we become familiar with all of our member organizations and this is a wonderful way in which to accomplish that goal. Our first organization that will be highlighted is **The Rainbow Society of Alberta**. Roxanne Rosenberg, one of our Board Members, has prepared the following information about her organization. Thanks Roxanne!

The Rainbow Society of Alberta

The Rainbow Society was originally founded in Winnipeg in 1983, and was the first wish granting organization of its kind in Canada. In December of 1985, our founders approached the Winnipeg foundation with the intention of establishing an Alberta Chapter. In early 1986, the Winnipeg foundation was contacted by members of the Edmonton Activettes, the ladies affiliate of the Active 20-30 Club, a service organization working with those less fortunate, specifically mentally and physically handicapped children. The Activettes had an excess of funds they had raised through various fund raising activities and were looking for a new project to fund. Their call to the Winnipeg office was to offer financial support should an Alberta chapter of the Society be formed. Little did they know at the time that steps were already underway to form an organization in Alberta. Fate brought everyone together and, in June of 1986, the dream became a reality and the **“Rainbow Society For the Welfare of Sick Children of Alberta”** was formed. Initially, we operated under the Winnipeg umbrella, sharing their tax number and a joint audit.

In January of 1988, we received our own charity status and began operating separate and apart from the Winnipeg organization.

In June of 1992, our name was legally changed to *The Rainbow Society of Alberta* and we haven't looked back since. We are completely autonomous, serving the children of the province of Alberta, with a mandate “To provide wishes to Alberta children, between the ages of three (3) and 18 years, who have been diagnosed with a life-threatening or chronic illness.” For our purposes, we have further defined chronic to mean a medical condition which severely impacts and restricts the child's activities of daily living. The impact and restrictions may result from a variety of factors including, but not limited to, recurrent hospital stays, use of oxygen and/or ventilator machines, the need to use a wheelchair for mobility, high doses of medications or the need for a considerable degree of medical intervention. Any child who has been in remission or off treatment for a period exceeding two years will not qualify for our program.

Our original staff consisted of an Executive Director who worked part-time. Over the years, we've seen growth throughout the province and our staff now sits at 7 full time people, with our Head Office located in Edmonton and regional offices in the southern and northern regions. We are governed by a volunteer Board of Directors who provide us with invaluable support and guidance, and of course, our network of volunteers throughout the province enable us to keep moving forward successfully.

Since our inception, we have approved more than 800 wishes for some very special children. We believe that the dreams are as unique as the children who have dreamt them, and the wishes have ranged from such things as meeting a favoured athlete or entertainment celebrity, back yard play centres, cruises, computers, puppies, hot tubs,

shopping sprees, family reunions, musical instruments, a full-sized, custom-made suit of armour and a fully fenced basketball court. Of course, the most requested wish is, and always has been, for a family trip to Disneyland or Disney World.

One of our most exciting wishes was realized in June of 2008 when we were able to send a young boy to Ottawa to meet with Prime Minister Stephen Harper. Niklas had a full day on Capital Hill, with a private tour of the House of Commons, and a chance to watch the House in session, culminating with a private meeting with the Prime Minister. Niklas was also treated to a specially prepared luncheon, with all his favourite foods, in the Parliamentary Restaurant. The next day, Niklas was picked up from his hotel by an RCMP squad car and treated to a full day at the RCMP headquarters. He was able to tour the DNA lab, watch the bomb squad in action, ride in the RCMP helicopter and tank and had a private showing of the world famous RCMP Musical Ride. It was a two-day adventure that Niklas won't ever forget.

We are governed by a volunteer Board of Directors who provide us with invaluable support and guidance, and of course, our network of volunteers throughout the province enable us to keep moving forward successfully.
